
5. Boosts Confidence and Mental Well-being

Name of instruments

- 1. Mixing grinder: To grind dried herbs like Bitter guard, sandalwood, aloe vera, fullers earth, turmeric into fine powder.
- 2. pH Meter: A pH meter is used to measure the acidity or alkalinity of the face pack mixture.
- **3. Morter and pester:** For crushing and grinding smaller quantities of herbs manually.
- **4. Sieve:** To ensure the powders are fine and lump-free for smooth application.
- **5. Weighing scale:** To weigh herbs and powders for formulation in accurate proportion.
- **6.** Packaging equipment: Fills the paste into tubes, jars or bottles without air bubbles.

- 3. Weigh accurately kaolin, fuller earth, turmeric powder, them together to form uniform mixture
- 4. After that, the powder is run through a sieve machine, and to create a consistent face pack drug powder, previously made herbal medication and triturate are added.
