ABSTRACT

Intertigo is a skin inflammation, usually occur in moist areas, mainly between skin folds. The etiology is still unknown. Intertigo causes itching, burning and it may occur for long period of duration. Homoeopathy has a great role in treatment of Intertigo. A 45 years, old women came to OPD with a complain of severe itching in between fingers. A complete case was recorded and studied thoroughly and after repertorization, on the basis of individualization and totality of symptoms pulsatilla was prescribed. The aim of article is to show the effectiveness of pulsatilla in the case of Intertigo.

INTRODUCTION

Intertrigo is an inflammatory skin condition caused by rubbing of one area of skin on another mainly affect skin's flexural surfaces,

intensified by warm temperature, moisture, maceration and poor ventilation. Mainly affect axilla, inframammary creases, perineum and between fingers. Characteristically, the lesions are erythematous patches of various intensity with secondary lesions appearing as the condition progresses.[1]

Symptoms of intertigo [2]

- Red or brown rash
- Raw, itchy, or oozing skin.
- Offensive odour
- Cracked skin.

Intertrigo may appear in any of skin folds (Flexure surface) that have more moisture. In infants, (Diaper rash) represent as intertigo.

Pathophysiology^[3]

The 2 factor environmental factors and genetic causes play a major role in development of intertigo. One of these factors is the friction caused by adjacent skin surfaces causing inflammation of the superficial epidermis. Flexor surface have a higher surface temperature compared to other body parts. The moisture and sweat build-up that gets trapped in these areas adds to the maceration of the stratum corneum and epidermis. Additionally, flexor surface houses bacteria and yeast that flourish in this environment and overgrow in these conditions, making infection a common finding.

CASE STUDY

Mrs. XX, 45 year's old married hindu female belonging from middle socioeconomic status reported at OPD, complain of itching with redness between fingers of both hands. On further enquiry, it will illuminated that itching start after doing any household work in water.

The patient had family history, sister is suffering from Asthma and mother has been suffering from hypertension/ alive and father is not alive.

The patient having whitish complexion, teacher by profession and living happily with spouse and 2 children.

The mental general reflected highly emotional, cries readily, very gentle and mild with religious melancholy.

The physical general reflected as thirst decreased, thermally warm blooded, scanty perspiration which is non offensive and non staining, sleep position lies with hands above head. The pt. seeks open air, always feel better there.

Analysis of case

Mental general: Highly emotional, cries readily, very gentle, mild, religious.

Physical general: Thirstless (Drink from knowledge), thermally hot, scanty perspiration, sleep position lies with hands above head, desire open air.

Common symptom: Itching more in water and between fingers.

Evaluation of case

Highly emotional (Excitement)


Sleep hands above head

Selection of medicine (With reason)

After going through textbook of materia medica. Pulsatilla is hot chronically so, choice of medicine is selected.

Selection of potency

Potency (200) is selected on the basis of patient susceptibility because of strong mental generals.

Irritated skin folds should be patted dry, rather than wiped or rubbed. Apply coconut oil.
