improve immune homeostasis. This review critically evaluates the role of Panchakarma in autoimmune disorders through classical Ayurvedic concepts and contemporary scientific evidence. Therapies such as *Vamana*, *Virechana*, *Basti*, *Nasya*, and *Raktamokshana* demonstrate anti-inflammatory, immunomodulatory, detoxifying, and rejuvenating effects. Clinical studies suggest improvement in rheumatoid arthritis, psoriasis, ankylosing spondylitis, inflammatory bowel disease, and autoimmune neurological disorders following Panchakarma interventions. Panchakarma may serve as an effective integrative therapeutic approach alongside conventional medicine. Further multicentric randomized controlled trials are required to establish standardized treatment protocols and mechanistic validation.
